### **Business:**

<u>Motion to make the Trustee EIN available</u> for Paypal accounts of WSC approved committees with the following provisos:

- The committee's paypal account is linked to a trustee bank account. This account will be held solely for the ability of the committee to not only receive but send funds with their paypal account
- The committee will include reports of paypal income and payouts as part of their monthly report to the UAWSC E Trustees
- No trustee may transfer funds to that bank account without group conscience of the committee for whom it was opened
- No trustee may take any action in the paypal account other than downloading reports or taking an action (ie making a payment) on behalf of the committee.
   That action must be expressly authorized by group conscience of that committee
- If the trustees have concerns about the responsible use of the paypal account, they will, with the utmost respect, dialog on Zoom or other conferencing app, with the committee (including all committee members who desire to be present).

 If there is any dispute that can not be resolved in such a manner an immediate WSC convocation session of 1 hour will be called at a time agreeable to the GSR Committee for the resolution of the dispute (because the WSC is the GSRs and theTrustees).

# Background

• The 2020 ratified trustees used financial arguments in their attempt to deprive the fellowship of WSC 2021. They subsequently used their legal control of the 501c3 (and promoted a fear of legal exposure) as justification to govern and threaten the committees in the service structure and individual members of the fellowship. Because of these actions, the UA WSC E Trustees felt it prudent to build safeguards into any action involving the sharing of resources that has the potential for legal exposure. We believe (as it's described in the concepts and traditions) that it is the role of the Trustees to serve at the boundary between the fellowship and the rest of the world. Inside the fellowship we are guided by the traditions and group conscience. On the outside, so as to serve the practical necessities of the fellowship in the world, the trustees are accountable to the legal framework.

# GSRC Report for the UA WSC-Elected Trustees Meeting July 23, 2023

Greetings from the UA GSR Committee. I'm Fred A., GSR for the Sunday 11am Beginners Meeting currently serving as Co-Chair of the Committee with Dwight F, GSR for the Spiritual Marketing for Coaches and Consultants Meeting. Thank you all for your service and for allowing us to share our report today.

At the GSR Committee's meeting on Sunday, **July 9, 2023**, we had **34 members** in attendance, including 27 GSRs, 2 GSR Alternates; 2 WSC Elected Trustees, and 3 Members-at-large, including a Committee Chair and an interpreter for our Farsi-speaking GSRs. The meeting was chaired by Dwight F.

After welcoming notes, reports were heard:

- Our newly formed Group Support Subcommittee met to start working on a Rotation of Leadership Chart, requested by several of our GSR's. The idea behind this template is to provide an effective way for groups to track their service roles and volunteers, with a list of all officer names, positions, requirements, terms and contact info. The Subcommittee is also considering developing a template for Zoom-based group meetings, as well as sample group meeting formats for phone and in person meetings. Once approved by the GSRC, we will be sharing these with the general membership. If you'd like to take part in these efforts, send an email to the GRSC at GSRcommittee4UA@gmail.com.
- Our Leadership Training Working Group continues to meet. The focus at the last
  meeting was on developing relational (vs. reactive) communication tools, styles, and
  principles to help UA members facilitate meetings, practice conscious listening, and deal
  with conflicts in positive ways. The Group is hoping to sponsor a couple 60-minute or a
  90-minute leadership training workshop at the upcoming World Service Conference this
  fall.
- Our Mediation Petition Working Group reported that despite several attempts to ask for the GSB Inc.'s participation in support of Mediation, honoring the now over 570 signatures gathered on the petition, to date we have had no response. We are extremely grateful for the WSC-Elected Trustees decision to publicly support and participate in mediation. Next steps are being discussed and we will update you as things develop.

If anyone would like to participate in any of our wonderful Subcommittees and Working Groups, please reach out by email to us.

In our new business, we:

- Approved our spending plan for July 2023 to June 2024. Thank you David and Debora for your work in preparing and presenting the plan for approval, details of which are available in our meeting notes;
- We had a 20-minute session where GSR's were allowed to share feedback and thoughts on next steps regarding the Petition to Mediate, in light of the GSB's lack of response to date. No motions however were made at this point;
- A motion to Amend the Suggested Duties and Qualifications of UA GSRs was
  postponed for consideration and possible approval at our August meeting. If approved,
  the motion will be recommended for placement on the WSC 2023 agenda.

3. Attendance is free to those who perform service as a moderator or speaker on a workshop, or for a 3 or more-hour tech shift on the conference.

\*Note – Requests have come in to consider options for people who want to attend a small portion of the conference but may be unable to perform service or the cost. This topic will be put

forth in upcoming WSC Planning Committee meetings for consideration.
