Motion to assemble a working group to redraft the UA Concepts for consideration at WSC 2023

<u>Background</u>: Underearners Anonymous has never passed a UA version of the concepts. While various groups have looked at rewrites, none has ever been brought to the World Service Conference to be voted on. The 12 concepts drafted by a handful of people and not approved by the whole fellowship have been a key element in the conflict within our fellowship.

Of the Topics of Concern responses, many touched on the continuing attempts (of some) to assert dominance and governance. We feel that if we continue to awkwardly waffle between using AA Concepts and unapproved UA concepts we are sustaining fertile ground for further conflict in the future.

Given the short time, the working group will focus solely on rewording the concepts that could be read in such a way that the Trustees can wield power that exceeds what is bestowed upon them by the Conference. The working group may continue to revise the Concepts if it is deemed necessary to bring further edits to WSC 2024. We hope that the working group will consider the Symptoms of Underearning as they make their edits. The trustees on the working group will be Evgeniy, Mehdi and Jessica and we invite a diverse group of GSRs and other fellows to participate.
